Block diagram

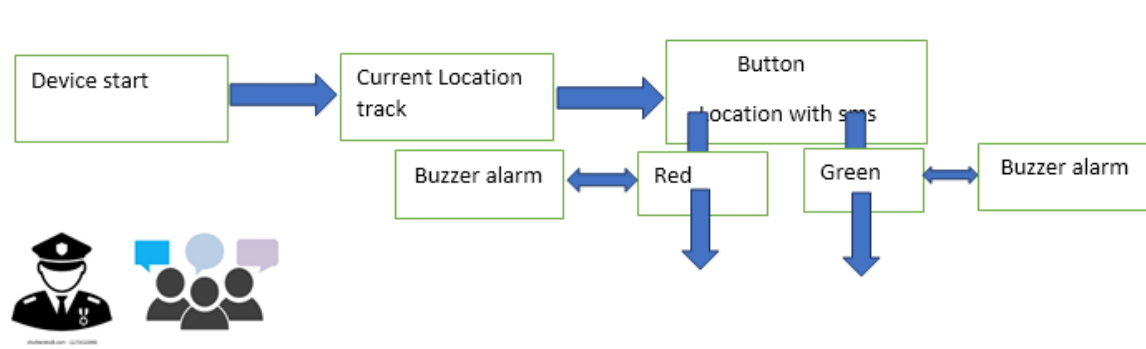


Figure 1- Block diagram for proposed system

useful or possible to reduce the harassment of woman. Women feel safety at the time of when she goes outside from home or whenever she is alone at anywhere.

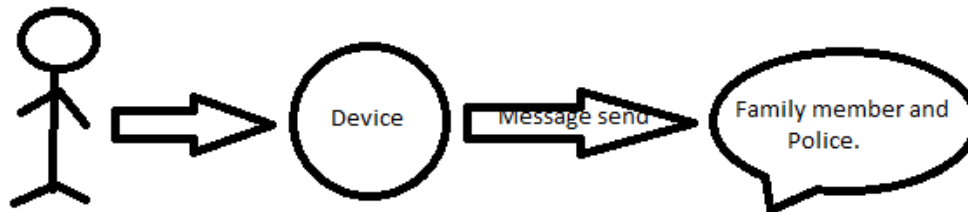


Figure 2- Working of system
